## COMPLETION OF INTERNALISATION

---

BWP Group ("**BWP**") is pleased to announce that it has successfully completed the internalisation of its management functions through the acquisition of BWP Management Limited ("**Internalisation**").

As part of the Internalisation, securityholders have been distributed shares in BWP Property Group Ltd on a one for one basis so they hold the same number of shares in BWP Property Group Ltd as they do units in the BWP Trust. The shares in BWP Property Group Ltd have been stapled to the existing BWP Trust units, making the securities in BWP stapled securities.

New holding statements, reflecting the new stapled entity structure, will be despatched to securityholders on 4 August 2025. BWP stapled securities will commence trading on the ASX on a normal settlement basis from 4 August 2025 under the same ASX ticker "BWP".
